

## Official Contest Rules (2024)

By entering the Holiday Coloring Contest (“Contest”), you and your parent or legal guardian (if applicable) agree to abide by the following rules:

1. **Skill-based Contest:** No purchase necessary. Winning is based on creativity and skill, not chance. Three winners (one per age group) will be selected from all entries.
2. **Eligibility:** Open to legal residents of Canada (excluding Quebec). Parent must submit entry for children under 13. Parental consent is required for entrants under 18. Void where prohibited.
3. **Entry Period:** Contest runs from 8:00 AM MST on December 1, 2024 to 4:00 PM MST on December 30, 2024. Entries must be submitted in person at Wetaskiwin or Falun Co-op.
4. **Entry Requirements:** Print or pick up a coloring sheet and submit a colored version using any artistic medium (crayons, pencils, markers, paints). Include your full name, age, phone number, parent’s contact details, and consent form if under 18.
5. **One Entry Per Person:** Only original entries created by the entrant will be accepted.
6. **Judging:** Entries will be judged based on creativity (50%) and coloring skill (50%). Winners will be selected from three age categories: 5 and under, 6-10, and 11-16.
7. **Winner Notification:** Winners will be contacted by phone or email in the week after December 30, 2024. Prize must be claimed within 10 business days or an alternate winner will be selected.
8. **Prizes:** Three winners (one from each age group) will receive a \$25 CDN Co-op gift card. If insufficient entries are received in any age group, the prize will be awarded to the group with the most entries.
9. **Eligibility Restrictions:** Employees of Wetaskiwin Co-operative and its divisions and their immediate family members are not eligible to enter.
10. **Publicity:** Winners agree to allow their name, city, and country to be posted on the sponsor's website and social media.
11. **Prize Substitution:** Sponsor may substitute prizes of equal or greater value.
12. **Liability:** By entering, participants agree to release the Sponsor from any liability related to the Contest and grant the Sponsor rights to use their entries for marketing purposes.

13. **Entry Conditions:** Entries must be original and must not infringe on third-party rights. Entries that violate laws or regulations will be disqualified.
